

Pool Committee Agenda Notes

May 3, 2022

Walkthrough complete, pools are in decent shape, Glen Eagles (GE) looks better inside than Oak Chase (OC).

Crystal Aquatics (CA) - Jeffrey Collins

- Will wait until complete OC roof before prepping pool
- Basketball goal @GE installed
- 2 new dive boards at GE. CA will keep packaging, boards arriving on 5/4
- Questions from the committee as to the age of the OC board and if we should send this board for inspection
 - CA will look at the cost to refurbish or replace the OC diving board
- Electrical inspection will occur after pools cleared
- Pre walkthrough preferable on Tuesday before opening on Memorial Day weekend
- Will plan on a Zoom meeting to meet the guards. Purpose of the meeting is to have the guards meet the pool committee and to set expectations. CA will work w/ Scott on the meeting dates.
- July Chronicle is the target for the lifeguard bios. Heather will send bio format to Casey
 - would need bio info by 6/10 to publish Scott
- Staffing no update
- Swim team coaches pool and operations classes status request by committee
 - Swim and dive teams have pool ops trained personnel covered but not for lifeguards
 - CA website has available courses
- Committee asked about the status of the OC pool cover, it seems to be in worse shape than GE.
 - There appear to be holes in OC cover and rips on the corners. What is cutoff date to order a new cover before Fall
 - CA recommended July, Committee will discuss in June meeting, pending estimate
 - Committee asked if there are other material options? CA does not recommend changing the pool cover material
- CA asked if Committee still want them to replace incandescent lights with LEDs at OC
 - LED requires replacement of fixture entirely
 - Committee recommend continue to replace with LEDs at OC and incandescent at GE

Maintenance Items

- Approval for circuit for flood light at OC, work completed
- OC Board discussion, replacement or refurbishment consideration for end of season

- Recommend new benches at GE and OC (2 benches at each pool); replace w/ composite materials
 - Would be replacement reserve funding?
 - Approx. \$3000 to replace
 - We have already ordered 2, will submit for board approval

Furniture Update

- New batteries in grid igniters, tanks are filled
- Remaining furniture arrives 5/10
- Pool housing roofing replacement occurring over next couple weeks, lots of improvements ongoing

Swim and Dive

- Suit fitting occurred
- Registration now online
- Swim/Dive revised schedule review
- Schedule almost identical to 2021
 - 3-A meets Saturdays (swim)
 - 4-B meets on Mondays (swim)
 - 3 home A- Dive meets
 - 2 home B- Dive meets
 - no 7 July meet
 - 4th of July B meet on Monday morning, done by 11:00
- Ice cream price may remain the same, concern w/ making change if over \$1
